## PRESS RELEASE – BLACK REPARATION BANKING

### ic3 Crime Scene Investigators (ic3csi) Launch Global Support Campaign for Black-Led Reparatory Justice System

London, United Kingdom – 22 November 2025

The Reparation Nation Limited and its investigative arm, **ic3 Crime Scene Investigators (ic3csi)**, have launched a formal international campaign inviting major institutions to support the development of a Black-led reparatory justice framework and the proposed **ic3 Black International State (IBIS)**.

As part of this campaign, formal letters have been sent to key national and international bodies – including the **United Nations**, the **African Union (AU)**, the **Caribbean Community (CARICOM)**, the **UK Ministry of Justice**, and **NHS England** – asking them to consider providing **interest-free development loans, grants, donations, sponsorship, or partnerships** to support this work.

Each institution is being assigned a unique **Reparation Liability Tag (“TAG”)** in ic3csi’s records – for example, **REP-INT-UN\_UnitedNations**, **REP-INT-AU\_AfricanUnion**, **REP-INT-CARICOM\_CARICOM**, **REP-JUS-MOJ\_MinistryOfJustice**, and **REP-HEA-NHSEN\_NHSEngland** – marking them as entities whose relationship to Reparatory Justice for IC3 Black and IC6 Mixed-Black people is under structured review.

### BUILDING THE “BLACK REPARATION BANK”

ic3csi is a Black-led investigative unit that examines how institutions treat **IC3 Black** and **IC6 Mixed-Black** people, especially in areas where there are signs of **institutional racism and anti-Black racism**.

Whenever ic3csi sends a formal letter or email to an organisation, a **Debtor File** is opened or updated for that organisation and linked to its TAG. All responses – including silence – are recorded as evidence in what ic3csi calls the **“Black Reparation Bank”**.

Each Debtor File is treated like an account, documenting:

- The harms and concerns that have been raised
- The organisation’s responses or lack of response
- Its behaviour over time in relation to Reparatory Justice questions

In this way, every formal communication becomes both an investigatory step and a **potential future income event**, building a structured portfolio of possible Reparatory Justice claims.

---

## TOWARDS THE ic3 BLACK INTERNATIONAL STATE (IBIS)

The **ic3 Black International State (IBIS)** is being developed as an **independent Black authority** which will, in due course, review ic3csi's evidence and make decisions about Reparatory Justice liabilities.

IBIS is envisaged as the body that will:

- Confirm or release organisations from **stalemate** and **TAG** status
- Determine where real **Reparatory Justice Debt** exists and how it should be valued
- Issue and govern **Reparation Liability Tokens (RLT)** to record confirmed Reparatory Justice Debt
- Operate **Justice Trade Certification (JTC)** to guide how Black communities and allies trade with and engage with institutions based on their Reparatory Justice performance

ic3csi itself does **not** run payment systems, settle claims, or issue RLT or JTC. Its role is to investigate, document, and maintain the evidence base so that IBIS can later make formal and transparent decisions.

## QUOTE FROM JOHN CANOE (DERRICK LYNCH)

Founder and director **John Canoe, also known as Derrick Lynch**, said:

“For generations, Black people have been told that Reparatory Justice is either impossible or too complex to organise. ic3csi is our answer to that. We are building evidence, account by account, case by case, in a way that can eventually support a proper Black authority – the ic3 Black International State – to make clear, lawful, and transparent decisions about what is owed and to whom.”

He added:

“We are asking powerful institutions to do something very simple and very rare: to support a Black-led system of investigation and accountability without trying to own it. An interest-free development loan or grant from organisations like the United Nations, African Union, CARICOM, the UK Ministry of Justice, or NHS England would not be a handout – it would be an investment in an orderly, evidence-based future for Reparatory Justice.”

## **SAFEGUARDS, EQUALITY, AND INSTITUTIONAL RESPONSIBILITY**

In all letters, ic3csi is asking recipient institutions to **explain in writing** what **safeguards** they have in place to protect **IC3 Black and IC6 Mixed-Black people** in their decision-making processes.

This includes requests for:

- Identification of key decision-makers
- Details of equality impact assessments and review schedules
- Explanations of how decisions are recorded and communicated
- Evidence of compliance with equality and human rights duties and internal inclusion policies

John Canoe said:

“I am an IC3 Black person who has been classified as disabled by IC1 White people. My experiences with UK systems – including justice, health, and mental health – have made it very clear that anti-Black racism and institutional racism are not abstract ideas. They are lived realities with paperwork attached. That is why I insist on written communication and on proper safeguards for IC3 and IC6 people in all decision-making.”

## **WHAT THE SUPPORT WOULD FUND**

Support from institutions is being sought to:

- Expand ic3csi’s investigative and documentation capacity (research, analysis, correspondence, and evidence storage)
- Develop the organisational and legal foundations required to bring **IBIS** into full existence as an independent, accountable Black authority
- Produce education and readiness materials so institutions can understand **TAGs, Debtor Files**, and future **IBIS** and **RLT/JTC** processes

It is envisaged that, when IBIS is formally established and operational, it will assume responsibility for any **interest-free development loans** granted to support this foundational phase. Until then, **The Reparation Nation Limited** remains directly responsible to any supporting institution for the agreed principal and agreed reporting conditions.

## **A CALL TO INSTITUTIONS AND THE PUBLIC**

The campaign invites:

- **Governments, international bodies, and major institutions** to respond in writing to ic3csi's letters and consider providing interest-free development loans, grants, or other forms of support
- **Black communities and allies** to follow the development of ic3csi and IBIS, and to recognise that Reparatory Justice can be organised systematically, not just symbolically

John Canoe concluded:

“Every letter we send is logged. Every reply – or refusal to reply – is logged. This is not just protest; it is the careful construction of a Reparation Ledger that Black people control. We welcome any organisation that is willing to help finance that work **without** extracting profit from our historical and ongoing suffering.”

## **Summary**

IC3 Crime Scene Investigators (ic3csi) issues an urgent community safety alert to the IC3 (Black) and IC6 (Mixed-Black) community following a suspected police impersonation incident at 23 Jersey House, Enfield EN3 5UY on 31 October 2023 (~11:20–11:40). Four IC1 (White) males—dressed in clothing resembling City of London Police (including red-and-white chequered caps)—were inside the building without invitation, banged on doors, and spread fear. Their genuine identity has not yet been verified. Until written confirmation is provided by the authorities, treat this pattern as a potential impersonation threat.

## **Seasonal context (Halloween)**

Given the Halloween period and the increased prevalence of costuming/disguise, ic3csi cautions that hostile actors could exploit the season to intimidate IC3 Black and IC6 Mixed-Black residents, including by mimicking police appearance to gain entry or induce fear. ic3csi has a duty to inform and protect the community, and this alert is part of that duty.

## **Community Alert — Description**

- Number: Four males
- Appearance: IC1 (White)
- Clothing: Resembling City of London Police (incl. red-and-white chequered caps)

- **Behaviour reported: Entry to residential block without invitation, no doorbell use, loud knocking/banging on doors, reference to a “voluntary interview.”**

### **What To Do If Approached (Do Not Confront)**

1. Do not open the door. Speak through the door or intercom.

Verify identity: Ask for warrant/collar numbers, names, ranks, and force.

Call 101 yourself to verify in real time (call 999 if you feel in danger).

**Require doorbell use: If the visit is genuinely about you, insist they use the doorbell so you can view and record externally.**

**Written-only policy: You may state, “I require written-only contact except genuine emergencies.”**

**Record and preserve: Save doorbell/CCTV clips; note time/date/description; keep any cards/letters; ask neighbours what they saw.**

Report quickly:

Metropolitan Police (Enfield area): report suspected impersonation; request crime ref and CAD.

**Council (ASB/Housing): report anti-social behaviour on the estate; ask who let them in; request CCTV/access-log preservation.**

ic3csi: email evidence for coordination and safeguarding.

### **Statement from ic3csi**

**“As an IC3 (Black) resident, I stated on camera: ‘I have not refused a voluntary interview. I will attend once written safeguards are confirmed in writing.’ Until authorities verify identities and legal authority for attendance in Enfield, the four males are treated as suspected impersonators. We expect written assurances, full transparency, and preservation of CCTV/BWV/access logs. In the Halloween period, the community should be extra vigilant.” — Derrick Lynch (John Canoe), ic3csi**

## **Safeguards for IC3 Black & IC6 Mixed-Black Residents**

- Keep doorbell/CCTV working; enable motion alerts.
- **Use a household script: do not open; verify via 101; request written-only contact.**
- Share this alert with neighbours, tenants’ groups, and community leaders.

## **CONTEMPORANEOUS STATEMENT – TO ATTACH TO ALL EMAILS**

#### **Purpose of this statement**

**This statement records my account and positions regarding an incident at my home on 31 October 2023 involving four unknown males inside my building whose clothing (including red-and-white chequered caps) resembled City of London Police. I currently have no proof they were genuine police officers and therefore treat them as suspected impersonators until verified in writing. This statement accompanies my reports to Enfield Council (ASB & DPO), the Metropolitan Police Service (Enfield – North Area BCU), the City of London Police (PSD), and the IOPC.**

#### **Summary of the incident (short)**

- Date/Time window: 31 October 2023, approximately 11:20–11:40 (I refer to 11:15–11:50 for evidence preservation).**
- Location: Outside my flat door, inside 23 Jersey House, 2 Eastfield Road, Enfield EN3 5UY (Council premises).**
- Persons: Four unknown males inside the building; appearance consistent with City of London Police uniforms/caps, but identity unverified.**
- Approach: They did not ring my doorbell; they knocked on my door.**
- Contact: I spoke to them through my closed door. I did not invite them and did not let them in through the external door.**
- Framing by visitors: They used language of a “voluntary interview.”**
- My position on camera: “I have not refused a voluntary interview. I will attend once written safeguards are confirmed in writing.”**
- Impact: The attendance caused harassment, alarm, and distress to me as an IC3 (Black) resident and potential concern to neighbours.**
- Key unknown: Who let them into the building? I require Council confirmation from CCTV and access logs.**

#### **Detailed timeline (approximate)**

- ~11:20 – Knocking at my flat door (no doorbell activation).**

- I view and engage through the spy hole/closed door. The speaking male states/uses language indicating attendance for a “voluntary interview.”
- I state that I have not refused and that I will attend once written safeguards are confirmed.
- I refer to my standing policy (written previously) that I do not do face-to-face meetings with police, except genuine emergencies, due to concerns about anti-Black racism and institutional racism.
- I request that what I say be placed on the record.
- I observe what appeared to be a deactivation of the speaking male’s body-worn camera indicator while I was speaking (indicator ceased showing active).
- ~11:40 – The four males depart.

#### **My standing safety policy (prior and ongoing)**

**Because of well-documented concerns regarding anti-Black racism and institutional racism, I require: Written-only contact by police (email or post), except genuine emergencies; and**

**If attendance is claimed, doorbell must be used so I can engage outside and refuse entry to protect residents.**

This policy had been previously communicated in writing.

#### **Why I treat them as suspected impersonators (until verified)**

- I did not see warrant/collar numbers.
- They did not ring my doorbell, preventing me from verifying identity via my camera workflow.
- I have no written confirmation from any force that a lawful deployment to my address occurred on 31/10/2023 in Enfield.
- Therefore, until verified by City of London Police and/or MPS, I reasonably treat them as suspected impersonators and a threat to my safety.

#### **Jurisdiction and authority (verification needed)**

- The incident occurred in Enfield (Metropolitan Police territory).
- **If the visitors were genuine City of London Police, I require written proof of any mutual-aid/tasking/jurisdictional authority enabling attendance in Enfield at the stated time.**

**Evidence likely to exist (preservation requested)**

1. **Enfield Council CCTV – external entrances; internal lobbies; corridors; stairwells; lifts; approaches to my flat, 11:15–11:50, 31/10/2023.**
2. **Access-control & concierge records – fob/door logs, contractor key books, visitor sign-in/out, and any communications granting access.**
3. **Body-Worn Video (BWV) – if they were genuine police, there should be per-officer footage with activation/deactivation timestamps and audio.**
4. **CAD/incident logs, radio/telephony – records of attendance/tasking and any cross-force authorisation.**
5. **Officer notebooks/briefings/risk & equality paperwork – including PSED considerations.**

**My requests (consistent across agencies)**

- **Enfield Council (ASB & DPO): Log as hate-related ASB on Council premises; issue a case reference.**
- **Preserve and disclose CCTV and access/concierge records for 11:15–11:50.**
- Confirm who let them into the building and the entry route.
- Adopt protocol: doorbell must be used for any party claiming to attend for me.
- 
- **Metropolitan Police Service (North Area BCU – Enfield): Register a crime for suspected impersonation of a police officer (Police Act 1996 s.90) and record harassment/alarm/distress as hate-related (Equality Act 2010/PSED monitoring).**
- Issue crime reference and CAD; name a contact officer.
- **Verify any lawful deployment by any force to my address on 31/10/2023 and coordinate evidence with Enfield Council.**

- City of London Police (PSD): **Confirm whether deployment occurred to my address on 31/10/2023 ~11:20–11:40.**
- **If yes: provide CAD/incident, officer identities (name/rank/collar/unit), BWV references with timestamps, jurisdictional basis, and PSED/briefing documents.**
- If no: confirm no deployment so MPS can proceed with an impersonation investigation.
- 

IOPC: Take oversight notice and advise if additional materials are required.

#### **Safeguards for any future contact (unchanged)**

- **My recorded position (on camera): “I have not refused a voluntary interview. I will attend once written safeguards are confirmed in writing.”**
- **Safeguards sought include: written pre-brief (allegation/time window/scope), daytime neutral venue, my legal representative present, full audio provided to me, officers identify themselves (name/rank/collar) at outset, BWV on for all contact outside the interview room, reasonable time to review disclosure, and option to provide written responses.**

#### **Harm and remedy**

- **The incident caused harassment, alarm, and distress to me as an IC3 (Black) resident and affected my sense of safety at home.**

I seek: Immediate evidence preservation and verification of identities and authority.

Correction of any false record suggesting I “refused” a voluntary interview.

Compensation for distress once responsibility is established (police or impersonators).

**Preventative measures (doorbell protocol; written-only contact except emergencies).**
